**ARTICLES OF ORGANIZATION OF  
BRIDGES, LLC**

The undersigned, acting as organizer of a limited liability company under the South Dakota Limited Liability Company Act, does hereby adopt the following Articles of Organization for such Limited Liability Company.

**ARTICLE ONE**

The name of the Limited Liability Company is Bridges, LLC.

**ARTICLE TWO**

The period of duration of this Limited Liability Company is perpetual unless dissolution of the Limited Liability Company occurs in accordance with the provisions of its Operating Agreement.

**ARTICLE THREE**

The purpose for which the Limited Liability Company is formed is to engage in any lawful act or activity for which limited liability companies may be organized, including but not limited to a consulting company.

**ARTICLE FOUR**

The Limited Liability Company shall have those powers provided for in the South Dakota Limited Liability Company Act.

**ARTICLE FIVE**

The address of the initial designated office of the Limited Liability Company is 4904 Oxbow Avenue, Suite 305, Sioux Falls, SD 57106. The initial registered agent of

the Limited Liability Company is Paul Erickson at 4904 Oxbow Avenue, Suite 305,  
Sioux Falls, SD 57106.

#### **ARTICLE SIX**

The Limited Liability Company shall have no managers, but shall be managed by  
the members.

#### **ARTICLE SEVEN**

#### **ARTICLE EIGHT**

The initial Operating Agreement will be adopted by unanimous consent of the  
Members. The power to alter, amend, or repeal the Operating Agreement or adopt a new  
Operating Agreement is vested in the members by unanimous consent of the Members.

#### **ARTICLE NINE**

To the full extent permitted by South Dakota law, no Member of the Limited  
Liability Company shall be liable to the Limited Liability Company or the other  
Members for monetary damages for an act or omission in such Member's capacity as a  
Member of the Limited Liability Company, except that this Article does not eliminate or  
limit the Liability of a Member to the extent the Member is found liable for (i) a breach  
of the Member's duty of loyalty to the Company or its Members; (ii) an act or omission  
not in good faith that constitutes a breach of duty of the Member to the Company or an  
act or omission that involves intentional misconduct or a knowing violation of the law;

(iii) a transaction from which the Member received an improper benefit whether or not the benefit resulted from an action taken within the scope of the Member's office; or (iv) an act or omission for which the liability of a Member is expressly provided by an applicable statute. Any repeal or amendment of this Article by the Members of the Company shall be prospective only and shall not adversely affect any limitation on the Liability of a Member of the Company existing at the time of such repeal or amendment. In addition to the circumstances in which the Member of the Company is not liable as set forth in the preceding sentences, the Member shall not be liable to the fullest extent permitted by any provision of the statutes of South Dakota hereafter enacted that further limits the Liability of a member or manager of a limited liability company or of a director of a corporation. The foregoing elimination of the liability to the Limited Liability Company or the other Members for monetary damages shall not be deemed exclusive of any other rights or limitations of liability or indemnity to which a Member may be entitled under any other provision of the Articles of Organization or the Operating Agreement of the Limited Liability Company, contract or agreement, vote of Members and/or disinterested Members of the Limited Liability Company, or otherwise.

## **ARTICLE TEN**

Additional Members may be admitted only upon the unanimous consent of the Members and payment of the contribution to capital required by the Members.


## ARTICLE ELEVEN

Unless all Members of the Limited Liability Company otherwise agree, a Member, irrespective of the nature of his or her contribution, has only the right to demand and receive cash in return for his contribution to capital.
