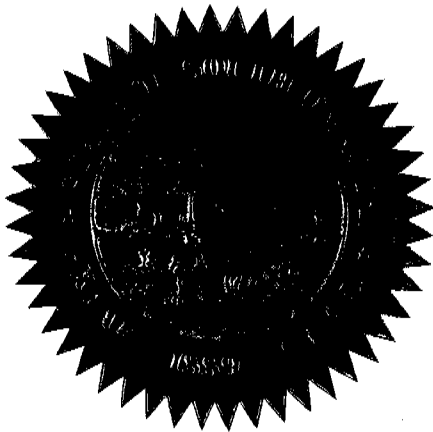

RACHELE MACK, the undersigned natural person of the age of Twenty-One years or more, acting as incorporator of a Corporation under the South Dakota Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I

The name of the Corporation is TIGER STEEL MART, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the Corporation is organized is as follows:

1. To operate a business for the sale, purchase, fabrication, and recycling of steel and other metals.
2.
