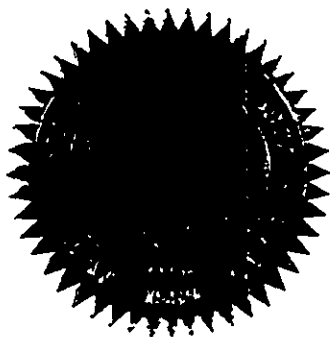

We, the undersigned, hereby associate ourselves together to form and establish a non-profit corporation under the laws of the State of South Dakota, and we make, execute and adopt the following Articles of Incorporation:

Article I.

Name: The name of this Corporation shall be the Yankton Christian Education Association, Inc.

Article II.

Term: The term of which this Corporation is to exist is perpetual.

Article III.

Purpose: The purpose of this Corporation shall be to establish and maintain a God-centered program of education in school or schools in accordance with Article IV of the Constitution of this organization, to receive, own, purchase, hold, convey, and mortgage property, both real and personal, for religious purposes; and to receive property by devise or any other means; and to transact any other business incidental to the advancement of the said purposes of this Corporation not prohibited by law. It is expressly stated that the objects, purposed and powers specified herein shall be regarded as independent objects and powers and that the enumeration of a specific power purpose and power shall not be construed to restrict in any manner the general terms and powers of the Corporation, nor shall the expression of any one thing be deemed to exclude the other, and these purposes incorporate those general terms of corporations granted by SDCL 47-22-52 through SDCL 47-22-68.

The Corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954.

#### Article IV

**Membership:** The affairs of this Corporation shall be managed by the school board who shall have the sole power and authority to act on behalf of the school and shall be elected by the membership of the corporation. The term "school board" shall have the same meaning as the "board of directors", as the term is used in the South Dakota Non-Profit Corporation Act
