ARTICLES OF INCORPORATION OF PFEIFER, INC.

S.D. SEC. OF STATE

EXECUTED BY THE UNDERSIGNED FOR THE PURPOSE OF FORMING A SOUTH DAKOTA BUSINESS CORPORATION UNDER THE LAWS OF THE STATE OF SOUTH DAKOTA.

ARTICLE I

The name of the corporation shall be PFEIFER, INC..

ARTICLE II

The period of existence is perpetual.

ARTICLE III

The purposes for which this corporation is organized are as follows:

- a) To buy, sell, lease, or trade real estate and personal property, to negotiate, sell, assign and convey notes, mortgages, and other securities necessary to conduct the business or businesses.
- b) To engage in and operate a ranch or ranches and a farm or farms which farming and ranching operations shall include, but are not limited to, the buying, raising and selling of livestock, the feeding and care of livestock, the production of hay, feed and other miscellaneous crops, the purchase of supplies, machinery, repairs and equipment and the maintenance of machinery and equipment, the building of fences and corrals and the maintenance and repair of same, the seeding of crops and harvesting of crops, the building of buildings and repair and maintenance of same, and the performance of such other tasks and duties as may from time to time be deemed necessary or convenient to carry out the purposes intended by the organization of this corporation and not inconsistent with the law;
- c) To buy and sell livestock on commission for others and to own, operate and lease trucks and other vehicles for shipping and storing livestock and other merchandise.
- d) To promote and exercise all or any part of the foregoing purposes and powers in any and all parts of the world, and to conduct its business in all or any of its branches as principal, agent, broker, factor, contractor, and in any other lawful capacity, either alone or through or in conjunction with any corporation, associations, partnerships, firms, trustees,

The authorized capital shall be \$1,000,000.00 and the corporation shall have authority to issue 1,000,000 shares of common voting stock with the par value of \$1.00 each. There are no preferences to the stock of this corporation. The liability of each shareholder shall be limited to the amount unpaid for his capital stock.

ARTICLE V

The authorized stock is of one class, and the issuance, relative rights, limitations with respect to the shares will be as provided by the By-Law. Three-fourths vote of outstanding shares is required to amend By-Laws.

ARTICLE VI

The corporation will not commence business until consideration of the value of at least one thousand dollars (\$1000.00) has been received for the issuance of shares.
