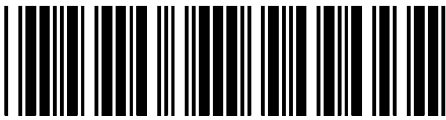
Article IX

- (a) Every person who was or is a party, or is threatened to be made party to or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that he, she or it is or was a manager, member, employee or agent of the company shall be indemnified and held harmless to the fullest extent legally permissible under the laws of the State of South Dakota against all expenses, liability and loss (including attorney's fees, judgments, fines and amounts paid or to be paid in settlement) reasonably incurred or suffered by him, her or it in connection therewith. Such right of indemnification shall be a contract right which may be enforced by such person in any manner provided by law. Such right of indemnification shall not be exclusive of any other right which such manager, member, employee or agent may have or hereafter acquire, and, without limiting the generality of such statement, such person shall be entitled to his, her or its respective rights of indemnification under any operating agreement or other agreement, vote of members, provision of law, or otherwise, in addition to his, her or its rights under this Section.
- (b) The expenses of any manager, member, employee or agent incurred in defending a civil or criminal action, suit or proceeding by reason of any act or omission of such manager, member, employee or agent as a result of acting as a manager, member, employee or agent on behalf of the company shall be paid by the company as such expenses are incurred and in advance of the final disposition of the action, suit or proceeding, upon receipt of any undertaking by or on behalf of the manager, member, employee or agent to repay such expenses if it is ultimately determined by a court of competent jurisdiction that he, she or it is not entitled to be indemnified by the company.
- (c) Without limiting the application of the foregoing, the members may adopt a provision in the operating agreement from time to time with respect to indemnification, to provide at all times the fullest indemnification permitted by the laws of the State of South Dakota, and may cause the company to purchase and maintain insurance or make other financial arrangements on behalf of any person who is or was a manager, member, employee or agent of the company against any liability asserted against such person and incurred in such capacity or arising out of such status, to the fullest extent permitted by the laws of the State of South Dakota, whether or not the company would have the power to indemnify such person.
- (d) The indemnification and advancement of expenses provided in this Section shall continue for a person who has ceased to be a member, manager, employee or agent of the company, and inures to the benefit of the heirs, personal representatives, executors and administrators of such person.
