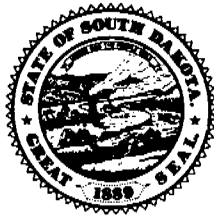

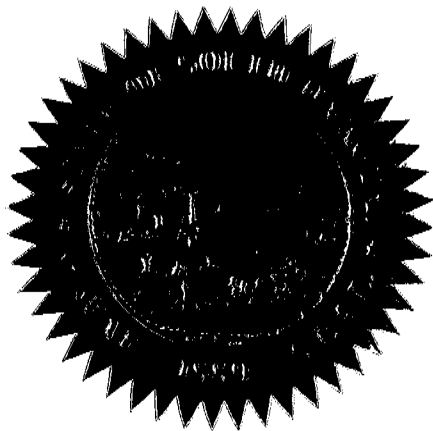

ARTICLES OF INCORPORATION

OF

All American Bird Seed, Inc.

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned Ryder Lemler, of 111 West Garfield Avenue, Gettysburg, South Dakota 57442, a natural person of the age of majority, for myself and my associates and successors, desire to form a corporation under and by virtue of the statutes and laws of the State of South Dakota, and I do hereby certify and declare as follows:

FIRST: The name of the corporation shall be "All American Bird Seed, Inc." and its registered office and initial principal place of business shall be 111 West Garfield Avenue, Gettysburg, Potter County, South Dakota 57442, and its initial registered agent shall be Ryder Lemler of 111 West Garfield Avenue, Gettysburg, South Dakota 57442; but said corporation may carry on its business at such other places, within or without the State of South Dakota, and may maintain branch offices and places of business within or without the said state, as the interest of its business may require.

SECOND: The term for which this corporation shall exist is perpetual.

THIRD: The purpose, or purposes, for which the corporation is formed are:

(A) To conduct and carry on the business of buying, selling and dealing in all kinds of grain, feed, seed or other farm produce, and farm products and provisions, and all other kinds of goods, wares, and merchandise and to do a general wholesale or retail business in any or all of the foregoing kinds of property, including, but not limited to, sales of bird seed.

(B) To purchase, receive by way of gift, subscribe for, invest in, and in all other ways acquire, import, lease, possess, maintain, handle on consignment, own, hold for investment or otherwise, use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, guarantee, contract in respect of, trade and deal in, sell, exchange, let, lend, export, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, assign, and in all other ways dispose of, design, develop, invent, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, produce, market and in all other ways (whether like or unlike any of the foregoing), deal in and with property of every kind and character, real, personal or mixed, tangible or intangible, wherever situated and however held, including, but not limited to, money, credits, choses in action, securities, stocks, bonds, warrants, script, certificates, debentures, mortgages, notes, commercial paper and other obligations and evidences of interest in or indebtedness of any person, firm or corporation, foreign or domestic, or of any government or subdivision or agency thereof, documents of title, and accompanying rights, and every other kind and character of personal property, real property (improved or unimproved), and the products and avails thereof, and every character of

interest therein and appurtenance thereto, including, but not limited to, mineral, oil, gas and water rights, all or any part of any going business and its incidents, franchises, subsidies, charters, concessions, grants, rights, powers, or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise in respect thereof all of the rights, powers, privileges and immunities of individual owners or holders thereof.

(C) To the extent permitted by law, to purchase, receive, lease as lessee and in any other manner acquire, own, hold, maintain, use, sell, convey, lease as lessor, exchange, mortgage, purchase or otherwise dispose of any and all real and personal properties, stocks or bonds of other corporations, or notes or mortgages of individuals, partnerships or corporations, or any interest therein which may be necessary or useful or appropriate to accomplish any or all the purposes of the corporation.

(D) To borrow money, to make and issue bonds, notes and other evidences of indebtedness, secured or unsecured, for leasing, borrowing and in payment of property acquired, or for any other objects or purposes of the corporation, and to secure the payment of such bonds, notes or other evidences of indebtedness by mortgage or mortgages, or deed, or deed of trust, upon or by the pledge of, or other lien upon all or any of the property, rights and privileges of the corporation, wheresoever acquired or to be acquired, when authorized, and upon such terms and conditions as may be determined by the Board of Directors without the vote or consent of the stockholders of the corporation.

(E) To do and perform either for itself or for its stockholders, any and all acts and things, and to have and exercise any and all powers that may be necessary or convenient to accomplish any or all of the foregoing purposes, or as may be permitted by the laws under which the corporation is formed.

(F) To hire and employ agents, servants, and employees, and to enter into agreements of employment and collective bargaining agreements, and to act as agent, contractor, trustee, factor, or otherwise, either alone or in company with others.

(G) To promote or aid in any manner, financially or otherwise, any person, firm, association or corporation, and to guarantee contracts and other obligations.

(H) To let concessions to others to do any of the things that this corporation is empowered to do, and to enter into, make, perform, and carry out, contracts and arrangements of every kind and character with any person, firm, association, or corporation, or any government or authority or subdivision or agency thereof.

(I) To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interests of this corporation.

(J) The foregoing clauses shall be construed as and shall be powers as well as purposes, and the matters expressed in each clause shall, unless otherwise herein expressly provided, be in no wise limited by reference to or inference from the terms of any other clause but shall be regarded as independent powers and purposes; and the enumeration of specific powers and purposes shall not construed to limit or restrict in any manner the meaning of general terms or the general powers of this corporation, nor shall the expression of one thing be deemed to exclude another not expressed, although it be of like nature. This corporation shall be authorized to exercise and enjoy all other powers, rights and privileges granted by the Business Corporation Act of this State, to corporations organized thereunder, and all the powers conferred by all acts heretofore or hereafter amendatory of or supplemental to that Act, either alone or in conjunction with other corporations, firms or individuals, either as principals or agents, and the enumeration of certain powers as herein specified is not intended as exclusive of or as a waiver of any of the powers, rights or privileges granted or conferred by that Act now or hereafter in force; provided, however, that nothing herein contained shall be deemed to authorize or permit this corporation to carry on any business, to exercise any power, or to do any act which a corporation formed under that Act may not at the time lawfully carry on or do. Provided, however, in the event of the occurrence in any of the foregoing clauses of this Article THIRD of any purpose, power or object prohibited by the laws of the State of South Dakota, or of any other state in which the corporation may carry on business shall not invalidate any other purpose, power, or object not so prohibited, by reason of contiguity or apparent association therewith.

FOURTH: The amount of the capital stock of the corporation shall be and is ONE MILLION DOLLARS (\$1,000,000.00) which shall be divided into Ten Thousand (10,000) shares of common stock at a par value of One Hundred Dollars (\$100.00) each, fully paid; and such shares of the capital stock in the corporation may be issued from time to time for cash, or property, or labor, or as may be determined from time to time by the board of directors.

(A) The holder of each share of common stock shall be entitled to one (1) vote for each share of stock which he owns.

(B) The corporation shall not commence business until consideration of the value of at least ONE THOUSAND DOLLARS (\$1,000) has been received from the issuance of shares.

FIFTH: The number of directors of this corporation shall be not less than One (1) nor more than Three (3) directors, as may be fixed by the By-Laws, who need not be stockholders, and the undersigned Ryder Lemler of 111 West Garfield Avenue, Gettysburg, Potter County, South Dakota 57442, shall be and constitute the first board of directors, and shall hold office until his successor or successors shall be elected and enter upon the discharge of his duties.


