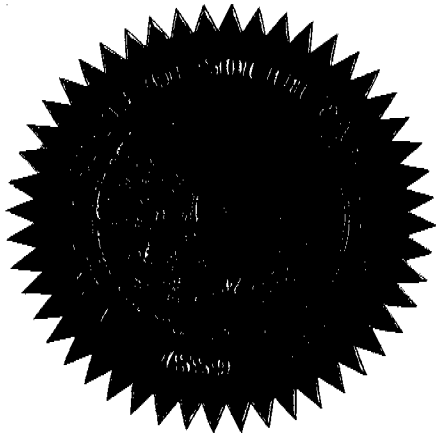

- (c) Any distribution to shareholders that is unlawful under the South Dakota Business Corporation Act or successor statute; or
- (d) Any transaction from which the director derived an improper personal benefit.

This Article does not limit or eliminate the liability of a director for any act or omission occurring before the effective date of this Article.

No amendment to or repeal of this Article may make any director of the Corporation personally liable to the Corporation or its shareholders for monetary damages for any act or omission as a director occurring before the effective date of that amendment or repeal.

This Article is intended to limit the liability of any director of the Corporation to the greatest extent authorized under the South Dakota Business Corporation Act. Any further limitation on the liability of directors authorized under any amendment to the South Dakota Business Corporation Act is incorporated into this Article on the effective date of that amendment.


**Article X**

The maximum indebtedness of this corporation shall be \$100,000,000.00.
