That we, the undersigned, REED INTERMILL and ALICE INTERMILL, for ourselves, our heirs, assigns and successors in interest, for the purpose of forming a corporation under and by virtue of the laws and statutes of the State of South Dakota, pursuant to the South Dakota Business Corporation Act and Title 47 of the South Dakota Compiled Laws of 1967, and Acts amendatory thereof, do hereby certify, declare and subscribe to these Articles of Incorporation which shall be as follows, to wit:

FIRST

FIFTH

Provisions for the regulation of the internal affairs of the corporation are:

(A) The holders of certificates of stock of REED INTERMILL TRUCKING, INC. may not sell said stock without first notifying the corporation in writing of a bona fide bid which has been received for the purchase thereof showing the name of the prospective purchaser; the corporation shall have an option for ninety (90) days from and after the receipt of said notice in writing to purchase any and all of such shares of stock at a price equal to 100% of the book value of said share or shares, and may be purchased by the other stockholders or any combination of them at a price equal to 100% of the book value of such share or shares, and in the event such option is not exercised within the ninety (90) day period, then the original prospective purchaser and the shareholder desirous of transferring any or all of his interest in the said corporation shall be entitled to complete the transaction as originally intended. Further, the corporation, or any group of shareholders, shall have a ninety (90) day option to purchase the shares of any shareholder transferring by means other than sale, that is, by gift, transfer at death, or any other means. The purchase price of each share in any such case as aforesaid is to be 100% of the book value of said share or shares. This article shall not apply, however, to transfer from an existing stockholder to another stockholder, nor in any way limit the right of individual

stockholders to enter into buy-sell agreements with each other and/or with the corporation.

(B) The holders of certificates of stock in REED INTERMILL TRUCKING, INC. may not offer, sell, or in any manner transfer such stock to any person or entity who or which is not qualified to hold stock under a valid election pursuant to the provisions of Subchapter S Internal Revenue Code Secs. 1371-1378; each individual shareholder is required to agree in writing that he will participate in all steps necessary for the corporation to make a valid election pursuant to the provisions of Subchapter S Internal Revenue Code Secs. 1371-1378 and further that he shall not take any action nor fail to do anything which would result in the forfeiture of the corporation's Subchapter S election.

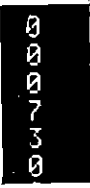

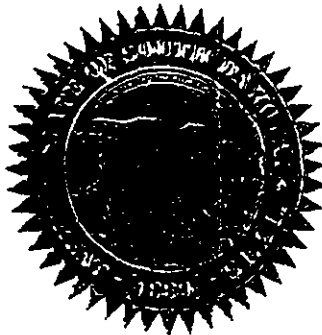
