The above-captioned matter came on for hearing before the Circuit Court in Webster, Day County, South Dakota, on the 17<sup>th</sup> day of December, 2008, at 1:15 p.m., pursuant to SDCL § 9-11-3 and SDCL § 9-2-1.

The Court having reviewed the Affidavit of Publication showing that the first publication of the Notice of Change in Classification was on November 24, 2008 and the second publication on December 1, 2008, and the Court having further reviewed the Application of the Mayor of the City of Bristol indicating that the population of Bristol is less than 500 persons and as set out in SDCL § 9-2-1, the City should pass into a different classification of a municipality. The Court further having heard argument of counsel and good cause there appearing, and hearing no objection to a change of classification,

IT IS HEREBY ORDERED, ADJUDGED and DECREED that the City of Bristol shall now become a third class city in accordance with SDCL § 9-2-1. This change of classification shall be effective as of December 17, 2008.
