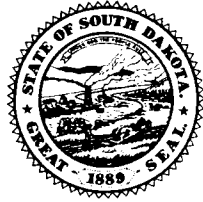

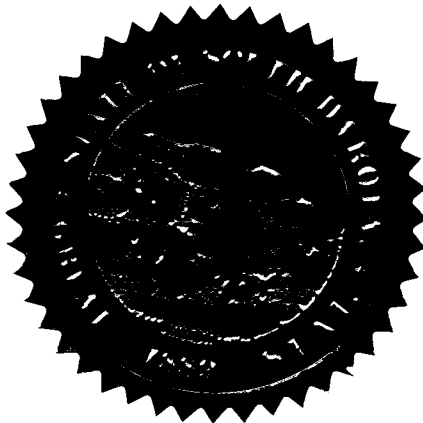

**ARTICLES OF ORGANIZATION
OF
BSW, L.L.C.
A LIMITED LIABILITY COMPANY**

We, the undersigned persons, who shall be members upon the issuance of a *Certificate of Organization* from the Secretary of State, acting as organizers of a Limited Liability Company under Chapter 47-34A of the South Dakota Codified Laws, hereby adopt the following *Articles of Organization* for such **BSW, L.L.C.**

**ARTICLE I.
Name**

The name of the Limited Liability Company is **BSW, L.L.C.**

**ARTICLE II.
Duration**

The period of duration of this Limited Liability Company shall be perpetual or until the earlier dissolution of the Limited Liability Company, in accordance with the provisions of its operating agreement.

**ARTICLE III.
Purpose**

The purpose for which the Limited Liability Company is organized is to conduct any lawful business, to promote any lawful purpose and to engage in any lawful act or activity for which limited liability companies may be organized under the laws of South Dakota, including but not limited to, operating an investment company.

**ARTICLE IV.
Rights**

The Limited Liability Company shall have those powers provided for pursuant to the laws of South Dakota.

**ARTICLE V.
Initial Designated Office and Registered Agent**

The street address of the initial designated office of the Limited Liability Company is: 2205 Clear Water Court, Aberdeen, South Dakota 57401 and the name of its initial registered agent at such address is Corey Sauerwein. The address of the principal place of business is 2205 Clear Water Court, Aberdeen, South Dakota 57401.

**ARTICLE VI.
Initial Capital**

The total amount of cash or real property initially contributed by the members will be Two Thousand (\$2,000.00) Dollars. There are two members in the Limited Liability Company for a total of \$2,000.00 to be contributed to the Limited Liability Company. This company is to be managed as a member managed company.

**ARTICLE VII.
Additional Contributions**

The members may provide in the Operating Agreement, that additional contributions shall be made at specified times and in specified amounts.

**ARTICLE VIII.
Admission of Additional Members**

Additional members may be admitted upon the majority vote of all members as provided in the Operating Agreement.

**ARTICLE IX.
Voting**

On each matter on which the membership interest is entitled to vote, a member will have one (1) vote or fraction of one vote per one percent (1%) of membership interest or fraction of membership interest owned by the member, as adjusted from time to time to properly reflect any additional contributions or withdrawals by the member. Corey Sauerwein shall have 50% of the membership interest and Jennifer Sauerwein shall have 50% of the membership interest.

**ARTICLE X.
Right of Continuation**

Upon the unanimous vote of the remaining members, as provided in the Operating Agreement, the Limited Liability Company may continue business upon the termination of the membership of a member caused by the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or occurrence of any other event which terminates the continued membership of a member.

**ARTICLE XI.
Operating Agreement**

An Operating Agreement will be adopted by the majority vote of the members. The power to alter, amend, or to repeal the Operating Agreement, or adopt a new Operating Agreement is vested in members by the majority vote of the members.

ARTICLE XII.
Succession by Heirs

In the event of a death of any member of the Limited Liability Company, the member's share and voting interest shall pass according to the member's will or other testamentary document, or by intestate succession under South Dakota Law. In no event may the deceased member's shares be sold or otherwise disposed of, except by majority vote of the original members who may, in their discretion, either solely or by the Limited Liability Company, purchase the deceased member's shares at a value determined as of the date of death or member with right of first refusal by original members. In the event of a death of a spouse or original member, surviving spouse, married at time of organization, shall be deemed an original member of the Limited Liability Company.

ARTICLE XIII.
Withdraw, Disposing or Encumbrance of Assets

No member shall dispose, withdraw from, or cause an encumbrance upon the assets and contributions of the Limited Liability Company, except as provided in the Operating Agreement or by majority vote of members.

ARTICLE XIV.
Management

The Limited Liability Company shall be a member-managed company pursuant to SDCL 47-34A-301(c) rather than manager managed. The manager of the Limited Liability Company is as follows:

ARTICLE XVI.
Internal Affairs

To the extent permitted by South Dakota Law, no Manager or Member of the Limited Liability Company shall be liable to the Limited Liability Company or its members for monetary damages for an act or omission in such Manager's or Member's capacity as a Manager or Member of the Limited Liability Company, except that this article does not eliminate or limit the liability of a manager or member to the extent the manager or member is found liable for (i) a breach of the manager's or member's duty of loyalty to the Company or its members; (ii) an act or omission not in good faith that constitutes a breach of duty of the manager or member to the Company or an act or omission that involves intentional misconduct or a knowing violation of the law; (iii) a transaction from which the manager or member received an improper benefit whether or not the benefit resulted from an action taken within the scope of the manager's or member's office; or (iv) an act or omission for which the liability of a manager or member is expressly provided by an applicable statute. Any repeal or amendment of this article by the members of the Company shall be prospective only and shall not adversely affect any limitation on the liability of a manager or member of the Company existing at the time of such repeal or amendment. The foregoing elimination of the liability to the limited liability company or its members for monetary damages shall not be deemed exclusive of any other rights or limitations of liability or indemnity to which a manager or member may be entitled under any other provision of the Articles of Organization, the Operating Agreement, contract or agreement, vote of members, or otherwise.

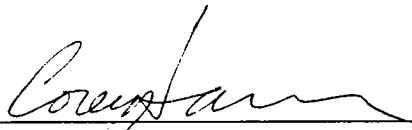

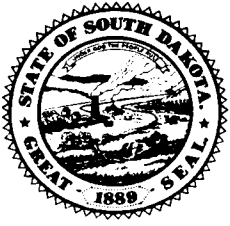
