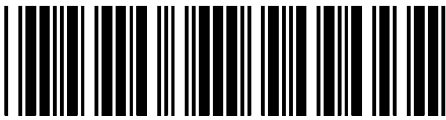
The purposes for which this corporation is organized, in addition to the corporate powers enumerated in the South Dakota Business Corporation Act, shall be as follows:

To acquire by purchase, exchange, lease, hire or otherwise hold, own, manage, operate, mortgage, pledge, hypothecate, exchange, sell, deal in and dispose of real and personal property of every kind, character and description whatsoever and wheresoever situated and any interest therein.
3. To make contracts; to enter into, make, perform and carry out or cancel and rescind contracts for any lawful purpose pertaining to its business.
4. To borrow funds; to borrow or raise money for any of the purposes of the corporation without limit as to amount; to execute, accept, endorse and deliver evidence of borrowing all kinds of securities including, but not limited to, promissory notes, drafts, bonds, debentures and other negotiable instruments and to secure the payment in full performance of such borrowing by mortgage, pledge, conveyance or assignment of the whole or any part of the assets of the corporation.
5. The corporation may also do all and everything necessary, suitable or proper for the accomplishment of any of the above purposes.
