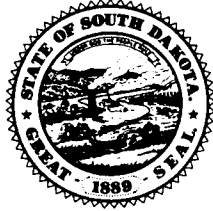

ARTICLES OF ORGANIZATION
OF

B & C Doerr LLC

(a South Dakota limited liability company)

The undersigned, pursuant to the South Dakota Uniform Limited Liability Company Act, SDCL Chapter 47-34A, hereby adopts the following Articles of Organization for a domestic limited liability company.

1. The name of the Limited Liability Company is: B & C Doerr LLC.

2. The duration of the company is perpetual.

6. The company shall be a manager-managed company rather than a member-managed company, and the names and addresses of the initial managers are:

7. No manager or member of the company shall be liable for its debts and obligations under SDCL 47-34A-303(c).

8. (a) Every person who was or is a party, or is threatened to be made party to or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that he, she or it is or was a manager of the company shall be indemnified and held harmless to the fullest extent legally permissible under the laws of the State of South Dakota against all expenses, liability and loss (including attorney's fees, judgments, fines and amounts paid or to be paid in settlement) reasonably incurred or suffered by him, her or it in connection therewith. Such right of indemnification shall be a contract right which may be enforced by such person in any manner provided by law. Such right of indemnification shall not be exclusive of any other right which such manager may have or hereafter acquire, and, without limiting the generality of such statement, such person shall be entitled to his, her or its respective rights of indemnification under any operating agreement or other agreement, vote of members, provision of law, or otherwise, in addition to his, her or its rights under this Section.

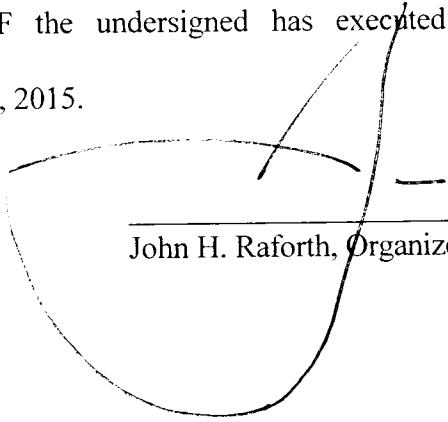
(b) The expenses of any manager incurred in defending a civil or criminal action, suit or proceeding by reason of any act or omission of such manager as a result of acting as a manager on behalf of the company shall be paid by the company as such expenses are incurred and in advance of the final disposition of the action, suit or proceeding, upon receipt of any undertaking by or on behalf of the manager to repay such expenses if it is ultimately determined by a court of competent jurisdiction that he, she or it is not entitled to be indemnified by the company.

(c) Without limiting the application of the foregoing, the members may adopt a provision in the operating agreement from time to time with respect to indemnification, to provide at all times the fullest indemnification permitted by the laws of the State of South Dakota, and may cause the company to purchase and maintain insurance or make other financial arrangements on behalf of any person who is or was a manager of the company against any liability asserted against such person and incurred in such capacity or arising out of such status, to the fullest extent permitted by the laws of the State of South Dakota, whether or not the company would have the power to indemnify such person.

(d) The indemnification and advancement of expenses provided in this Section shall continue for a person who has ceased to be a manager of the company, and inures to the benefit of the heirs, devisees, personal representatives, administrators, successors and assigns of such person.

9. No other provisions are included in these Articles of Organization.
