

ARTICLES OF INCORPORATION

OF

THAYER, INC.

Executed by the undersigned for the purpose of forming a South Dakota Corporation under Chapter 47 of the South Dakota Codified laws, more commonly known as the "South Dakota Business Corporation Act".

ARTICLE I

The name of the Corporation is THAYER, INC.

ARTICLE II

The period of existence is perpetual.
