South Dakota Law does not allow for extensions or the waiving of fees; the report(s) must be filed prior to the date cited above.

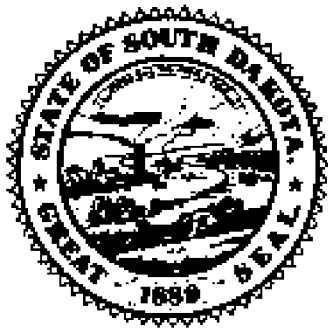
