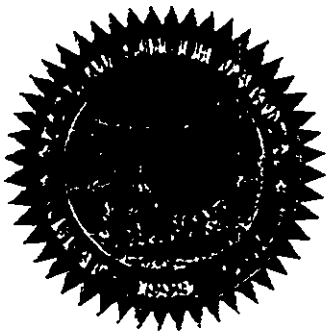



ARTICLES OF INCORPORATION
OF
ACL COMPANY OF SOUTH DAKOTA

I, the undersigned, for myself, my associates and successors, for the purpose of forming a corporation under and by virtue of the statutes and laws of the state of South Dakota, do hereby make, execute and adopt the following Articles of Incorporation.

ARTICLE I

NAME: The name of this corporation shall be ACL Company of South Dakota.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS: The place where the principal business of said corporation shall be transacted is 311 West Third Street, P. O. Box 708, Yankton, South Dakota 57078, other businesses may be established by the corporation at any place.

ARTICLE III

TERM: The term for which this corporation is to exist is perpetual.

ARTICLE IV

PURPOSE FOR WHICH FORMED: This corporation is formed for the purpose of operating a business which provides industrial services including services for industrial kilns and dryers and to do all other things which may in any way be connected with the operation of such types of businesses; to purchase, acquire, hold, sell, transfer, exchange or otherwise deal in shares of capital stock of this or other corporation or
