

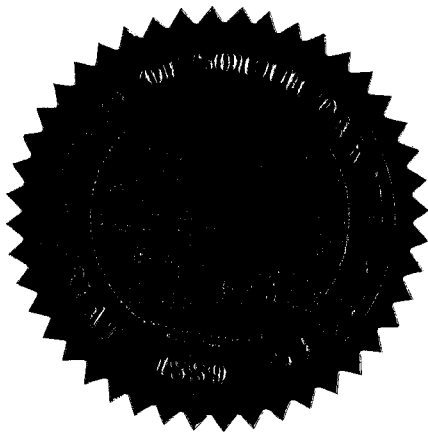

ARTICLES OF ORGANIZATION
A Domestic South Dakota Limited Liability Company

We, the undersigned one or more persons, acting as organizers of a limited liability company under the South Dakota Limited Liability Company Act, SDCL Chap. 47-34A, hereby adopt the following Articles of Organization pursuant to SDCL 47-34A-203 and deliver the same to the South Dakota Secretary of State for filing.

Mandatory Provisions Per SDCL 47-34A-203(a)

1. Name. The name of the limited liability company is

D & G Ventures, LLC

("Limited Liability Company").

2. Initial Designated Office. The address of the initial designated office, within or without the State of South Dakota, is 812 2nd Street, Britton, SD 57430.
3. Registered Agent. The name, actual street address in the State of South Dakota, and mailing address in the State of South Dakota of the non-commercial registered agent is David R. Christenson, 812 2nd Street, PO Box 103, Britton, SD 57430, who consents to act as such agent. [SDCL 59-11-6]
4. Organizers. The name and address of each organizer is:
- (a) David R. Christenson, 812 2nd Street, PO Box 103, Britton, SD 57430.
- (b) Gretchen H. Christenson, 812 2nd Street, PO Box 103, Britton, SD 57430.
5. Duration. The period of duration of this Limited Liability Company is perpetual unless there is an earlier dissolution of the Limited Liability Company in accordance with the provisions of its Operating Agreement.
6. Management By Members. The Limited Liability Company will be managed by the members.
7. Limited Liability. Pursuant to SDCL 47-34A-303(a) and to the fullest extent allowable under South Dakota law, the debts, obligations, and liabilities of the Limited Liability Company, whether arising in

contract, tort, or otherwise, are solely the debts, obligations, and liabilities of the Limited Liability Company. A member or manager is not personally liable for a debt, obligation, or liability of the Company solely by reason of being or acting as a member or manager. [SDCL 47-34A-303] In addition, a manager or member may also benefit from any other rights or limitations of liability or indemnity to which a manager or member may be entitled, whether available under any other provision of the Articles of Organization or the operating agreement of the Limited Liability Company, or by contract or agreement, or by vote of the members or disinterested managers of the Limited Liability Company, or otherwise. Any repeal or amendment of this paragraph by the members of the Limited Liability Company shall be prospective only and shall not adversely affect any limitation on the liability of a manager or member of the Limited Liability Company existing at the time of such repeal or amendment. This paragraph does not eliminate or limit the liability of a manager or member to the extent the manager or member is found liable for

- (a) Unlawful distributions pursuant to SDCL 47-34A-407;
- (b) A transaction from which the manager or member received an improper benefit, whether or not the benefit resulted from an action taken within the scope of the manager's or member's office;
- (c) A breach of the manager's or member's duty of loyalty or duty of care to the Limited Liability Company or its members;
- (d) An act or omission not in good faith that constitutes a breach of duty of the manager or member to the Limited Liability Company, or an act or omission that involves grossly negligent or reckless conduct, intentional misconduct, or a knowing violation of the law; or
- (e) An act or omission for which the liability of a manager or member is expressly provided by an applicable statute. [SDCL 47-34A-407; 47-34A-409]

Optional Provisions Per SDCL 47-34A-203(b)

- 8. **Powers.** The Limited Liability Company has those powers granted in the South Dakota Limited Liability Company Act. [SDCL 47-34A-112]
- 9. **Purpose.** The Limited Liability Company is organized is to conduct any lawful business, to promote any lawful purpose, and to engage in any lawful act or activity for which limited liability companies may be organized under the South Dakota Limited Liability Company Act, including, but not limited to, the purchase, development, sale, service, lease, and management of personal and real properties of all kinds and descriptions. [SDCL 47-34A-112(a)]
- 10. **Admission of Additional Members.** Upon unanimous agreement of all members and as provided in the operating agreement of the Limited Liability Company, additional members may be admitted on the terms and conditions specified in the operating agreement. [SDCL 47-34A-404.1(c)(7)]
- 11. **Right of Continuation.** Upon unanimous agreement of the remaining members and as provided in the operating agreement of the Limited Liability Company, the Limited Liability Company may continue business upon termination of the membership of any member. [SDCL 47-34A-603]
- 12. **Voting Rights.** On each matter upon which the membership interest is entitled to vote, a member will have one vote or a fraction of one vote per one percent or fraction of one percent of membership interest owned by the member, as adjusted from time to time to properly reflect any additional contributions to or withdrawals from capital by the member.
