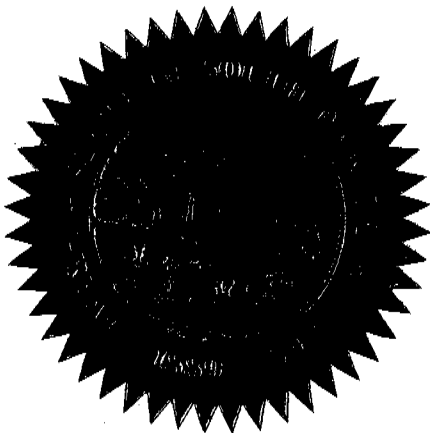

ARTICLES OF INCORPORATION
OF

SIOUX VALLEY ALUMNI & FRIENDS FOUNDATION, INC.

Executed by the undersigned for the purpose of forming a South Dakota nonprofit corporation under the laws of the State of South Dakota.

ARTICLE I.

The name of the nonprofit corporation shall be SIOUX VALLEY ALUMNI & FRIENDS FOUNDATION, INC.

ARTICLE II.

The period of existence of the nonprofit corporation shall be perpetual.

ARTICLE III.

The purpose for which the nonprofit corporation is organized is to promote, improve and provide educational and fundraising opportunities and activities for students, and community members through the funding and/or expansion of academics and co-curricular activities of the Sioux Valley School system; and to form and expand strong community connections between and among the various communities that are served by the Sioux Valley School system through fundraising, positive role modeling and structured activities, in accordance with SDCL 47-22-4, as is appropriate to the nonprofit and educational purposes and authority of the corporation.

The above-enumerated powers shall not be construed as limiting or restricting in any manner the powers of this nonprofit corporation, which shall always have such incidental powers as may be connected with or related to any specific power herein enumerated.

ARTICLE IV.

The number of memberships which this corporation shall have authority to issue is unlimited. The cost for each membership shall be \$5 annually.

ARTICLE V.

Any member, alumni or friend of the Sioux Valley School system and surrounding communities that wish to become a member of the nonprofit corporation will be permitted to do so. There are no specific qualifications for membership, other than the payment of annual dues and the desire to improve and expand the school system and promote the involvement and growth of the surrounding communities with education and the school system.

ARTICLE VI.

One third of the members on the Board of Directors shall be elected each year, over a three year staggered rotation, with each new term beginning the first week in August. Board members shall be elected by all of the current members of the nonprofit corporation who are present and vote, or submit proxy votes, at the annual meeting.

ARTICLE VII.

The name of the nonprofit corporation's registered agent is Ellie M. Vandenberg, Vandenberg Law. The address of the registered agent at the initial registered office is P.O. Box 78, Volga, South Dakota 57071. The registered agent hereby consents to the appointment as registered agent, and hereby consents to act as the registered agent of the nonprofit corporation.

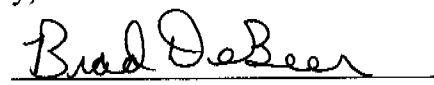

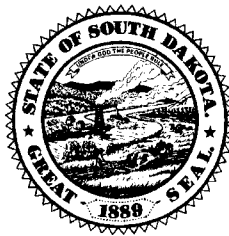

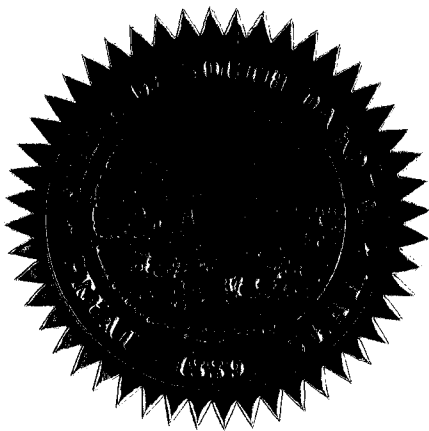
