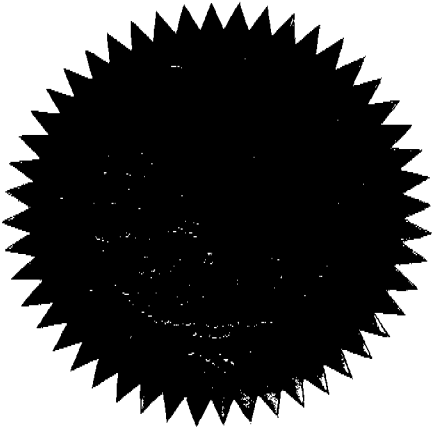

ARTICLES OF ORGANIZATION OF J & R RENTALS, L.L.C.

We, the undersigned person, who shall be members upon the issuance of a certificate of organization from the Secretary of State, acting as organizer(s) of a limited company under the South Dakota Limited Liability Company Act, do hereby adopt the following Articles of Organization for such Limited Liability Company.

ARTICLE ONE

The name of the Limited Liability Company is J & R Rentals, L.L.C.

ARTICLE TWO

The period of duration of this Limited Liability Company is perpetual from the date of the filing of these Articles of Organization with the Secretary of State or until the earlier dissolution of the Limited Liability Company in accordance with the provisions of its operating agreement.

ARTICLE THREE

The purpose for which the Limited Liability Company is organized is to conduct any lawful business, to promote any lawful purpose and to engage in any lawful act or activity for which limited liability companies may be organized under the South Dakota Limited Liability Company Act, including but not limited to, acquiring, purchasing, developing, subdividing, partitioning, conveying, leasing, and otherwise managing and dealing in real and personal property, or any other lawful purpose.

ARTICLE FOUR

The Limited Liability Company shall have those powers provided for in the South Dakota Uniform Limited Liability Company Act.

ARTICLE FIVE

The Limited Liability Company will not commence business until it has received the initial contribution for membership interest cash, property, or services.

The members may be required to make additional contributions, upon majority vote at the times and in the events upon which shall be agreed upon between the members in their operating agreement.

Additional contributions shall be made at such times and in such amounts as may be unanimously agreed by the Members as provided for in the Operating Agreement of the Limited Liability Company.

ARTICLE SIX

On each matter on which the membership interest is entitled to vote, a member will have one (1) vote or a fraction of one vote per one percent of membership interest or fraction of membership interest owned by the member, as adjusted from time to time to properly reflect any additional contributions or withdrawals by the member.

ARTICLE SEVEN

The street address of the initial registered office of the Limited Liability Company is 121 East SD Hwy. 50, P.O. ARTICLE EIGHT

The Limited Liability Company shall be managed by a group of managers. The number of initial Managers is two, and the names and addresses of the persons who are to serve as Managers until the first annual meeting of the Members or until their successors are elected and qualified are as follows: James E. Bouza of P.O. Box 303, Wagner, South Dakota and Roger Schroeder, of 502 Poplar Drive, Wagner, South Dakota.

ARTICLE NINE

ARTICLE TEN

The initial Operating Agreement will be adopted by unanimous consent of the Members. The powers to alter, amend, or repeal the Operating Agreement or adopt a new Operating Agreement is vested in the Members by majority vote of the members.

ARTICLE ELEVEN

To the full extent permitted by South Dakota law, no Manager or Member of the Limited Liability Company shall be liable to the Limited Liability Company or its Members for monetary damages for an act or omission in such manager's or Member's capacity as a Manager or Member of the Limited Liability Company, except that this Article does not eliminate or limit the Liability of a manager or member to the extent the manager or member is found liable for (i) a breach of the manager's or member's duty of loyalty to the Company or its members; (ii) an act or omission not in good faith that constitutes a breach of duty of the manager or member to the Company or an act or omission that involves intentional misconduct or a knowing violation of the law; (iii) a transaction from which the manager or member received an improper benefit whether or not the benefit resulted from an action taken within the scope of the manager's or member's office; or (iv) an act or omission for which the Liability of a manager or member is expressly provided by an applicable statute. Any repeal or amendment of this Article by the members of the Company shall be prospective only and shall not adversely affect any limitation on the Liability of a manager or member of the Company existing at the time of such repeal or amendment. The foregoing elimination of the liability to the Limited Liability Company or its Members for monetary damages shall not be deemed exclusive of any other rights or limitations of liability or indemnity to which a Manager or Member may be entitled under any provision of the Articles of Organization or the Operating Agreement of the Limited Liability Company, Contract or agreement, vote of Members and/or disinterested Managers of the Limited Liability Company, or otherwise.

ARTICLE TWELVE

Additional members may be admitted to the membership of the limited liability company upon unanimous consent of the members after the filing of the Articles of Organization, under the following conditions:

- a) That the new member be at least of eighteen years of age;
- b) That the new member agree, prior to purchasing his interest, that he will abide by all of the terms and conditions of these Articles, as well as the operating agreement of the limited liability company.

ARTICLE THIRTEEN

A) A member may withdraw from a limited liability company at the time or on the occurrence of events specified in the operating agreement. Except as otherwise provided by this act, the Articles of Organization or the operating agreement on withdrawal, any withdrawing member is entitled to receive, within a reasonable time after withdrawal, the fair value of that members interest in the limited liability company as of the date of withdrawal.

B) The remaining members of the limited liability company may continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or an occurrence of any other event which terminates the continued membership of a member in this limited liability company, based upon a majority vote of the members.

ARTICLE FOURTEEN

Any member of the limited liability company, irrespective of the nature of his contribution, and subject to the operating agreement between the members, has only the right to demand and receive cash in return for his contribution to capital.

ARTICLE FIFTEEN

These Articles of Organization may be amended, modified, supplemented or restated in any manner permitted by applicable law and approved by the affirmative vote of all of the membership interest.


